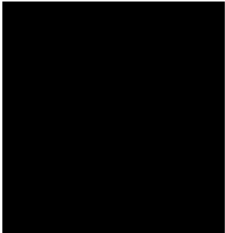

Well, keep up the good work Lynn, and think positive!

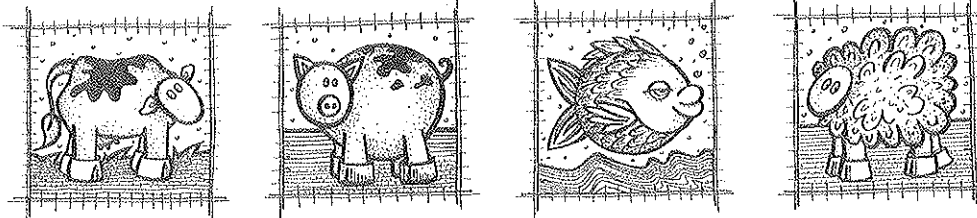

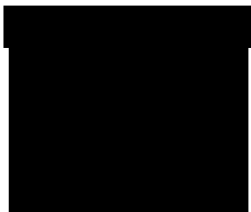

Dear Mr. Parker:

Pursuant to the state open records law, Or. Rev. Stat. sec. 192.410 to 192.530, I write to request access to and a copy of all medical records for rhesus macaque 20346. If your agency does not maintain these public records, please let me know who does and include the proper custodian's name and address.

I agree to pay any reasonable copying and postage fees of not more than \$10.00. If the cost would be greater than this amount, please notify me. Please provide a receipt indicating the charges for each document.

As provided by the open records law, I will expect your response within seven (7) days.

If you choose to deny this request, please provide a written explanation for the denial including a reference to the specific statutory exemption(s) upon which you rely. Also, please provide all segregable portions of otherwise exempt material.

Please be advised that I am prepared to pursue whatever legal remedy necessary to obtain access to the requested records. I would note that willful violation of the open records law can result in the award of litigation costs, disbursements and reasonable attorney fees.

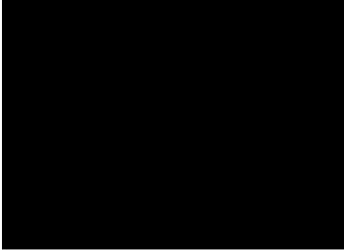
